  - According to the Food Service Adult Meal Pricing Requirements we need to increase the cost of an adult lunch effective January 1, 2022. The new minimum price is \$4.85 so we would like to increase the cost to \$5.00
  - ii. The current adult breakfast price of \$3.00 is still good for another year.
