3. Health Department Mask Order

The current Kalamazoo County Health Department order 333.2451 states that children in grades K-6 wear a mask while indoors for school. This order is effective immediately and remains in effect until six weeks past the date the COVID-19 vaccine is authorized and available to persons aged five years through eleven years. If the rates decline, KCHD said they will resend the order.
